I have upgraded to CleanMail 4.0.2.3 and I'm still having problems with blatantly obvious spam emails getting through CleanMail safe.

The following email scored 2.9 and we have the threshold score set to 3.0

I am Mr. Mark Howard From Harlsden, North West London, here in England. I work for Natwest Bank Corporation London. I am writing you about a business poposal that will be of an imense benefit to both of us. In my department, being the assistant manager Greater London Regional
