I am evaluating this software. However we use the Helm control panel software which uses Port 8086 for administration. It is not possible to change the port of Helm at this stage, since it is actively used by a number of our users.

Moreover, Nospamtoday tries to bind to all the interfaces of the server. If an option was available to selectively bind to a particular interface, the problem could have been avoided, by not letting Helm use other interfaces.

Is there a way to change the port number or interface setting in Nospamtoday?

At present, this setting is not accessible using the admin app. But to change the IP address and

port number of monitoring, you can edit the nospamtoday.cf file (located in the installation directory) with a text editor.

To use port 8087, add the following line in the [.../MonitornigPort] section:

```
IncomingPort="8087"
```

In the default setting, monitoring binds to the localhost interface, port 8086.

A TCP connection to the service's monitoring port is used by the admin app, to fetch statistics data from the service.

If you change the port, the service will bind to the other port. Once you restart the admin app, it reads the same cf file and knows that it should use some other port, not the default port, to get statistics data. So everything is the same, only the port actually used is different.
